


# Booking Conditions Private Tour – Chamonix, France 2027

Your contract is with ZEBRA ADVENTURES Limited. This document outlines the terms and conditions that apply when you book a holiday with us. You must read these conditions together with the holiday information provided because they define our obligations to you and also impose some important commitments on you. If any part of these booking conditions is found by any court or administrative body of competent jurisdiction to be invalid or unenforceable, such invalidity will not affect the other provisions which shall remain in full force and effect.

As Tour Operator, ZEBRA ADVENTURES is responsible for curating an unforgettable and insured tour, bringing experience, expertise, knowledge of the cultural aspects of Chamonix, France and its people, a phenomenal itinerary, Financial Failure Insurance (FFI), and we guarantee a personal service to every client that books with us to create a trip of a lifetime. ZEBRA ADVENTURES utilises a secure online booking system for all bookings, payments, and refunds. All fees payable in Pound Sterling (£) only.

#### **SUMMARY**

- To secure this private tour, a minimum of five (5) and a maximum of eight (8) participants are required.
- A non-refundable deposit of £850 (GBP) per person must be paid by all four (4) participants who opted in via the poll, before 25 January 2026.
- To proceed with the tour as planned, <u>all</u> remaining participants who will be joining this tour are required to pay the same non-refundable deposit of £850 (GBP) per person by 1 June 2026.
- Full payment of £4,200 (GBP) from all participants, minimum of five (5), maximum of eight (8), before 3 April 2027. For any cancellations on or after 3 April 2027, there will be NO REFUND.
- If a participant who has paid in full cancels before 3 April 2027, the non-refundable deposit of £850 will be retained as a cancellation penalty. The remaining balance will be refunded, minus a 3.7% administrative fee.
- If the group does not meet the minimum requirement of five (5) participants, ZEBRA ADVENTURES will cancel the tour on 3 April 2027. In this case, the non-refundable deposit of £850 (GBP) per person will be retained by ZEBRA ADVENTURES as a cancellation penalty.
- If five bookings have already been paid in full, there is no obligation to fill a fully paid booking that is cancelled after 3 April 2027.



#### 1. Tour Date

# 2. Tour Asking Price

£4,200 (GBP) per person sharing.

### 3. Deposit

A non-refundable £850 (GBP) per person deposit at booking. A non-refundable deposit can be carried over to another person by notifying ZEBRA ADVENTURES in writing and accepted once confirmed by ZEBRA ADVENTURES.

To secure this private tour, I kindly ask that the four (4) participants who opted in via the poll pay their non-refundable deposit of £850 (GBP) per person by 25 January 2026. Additionally, <u>all</u> remaining participants who will be joining the Chamonix tour are required to pay the same non-refundable deposit of £850 (GBP) per person no later than 1 June 2026.

# 4. Full Payment

Full payment of £4,200 (GBP) from all participants, minimum of five (5), maximum of eight (8), before 3 April 2027.

### 5. Cancellations

- 5.1 If the group does not meet the minimum requirement of five (5) participants, ZEBRA ADVENTURES will cancel the tour on 3 April 2027. In this case, the non-refundable deposit of £850 per person will be retained by ZEBRA ADVENTURES as a cancellation penalty.
- 5.2 If your tour is cancelled due to unforeseen circumstances on our part, ZEBRA ADVENTURES will refund all payments made.
- 5.3 It is not required to fill a fully paid booking cancelled after 3 April 2027 IF five (5) bookings were already paid for in full.
- 5.4 If a participant who has paid in full cancels before or on 3 April 2027, the £850 non-refundable deposit will be retained as a cancellation penalty. A refund of the remaining balance, minus a 3.7% administrative fee, will be issued.
- 5.5 For any cancellations on or after 3 April 2027, there will be NO REFUND.
- 5.6 Force Majeure For cancellations due to Force Majeure after 3 April 2027, refunds (minus 3.5%) will only be issued if our suppliers provide a refund. We advise consulting your Travel Insurance.

# 6. Bookings

ZEBRA ADVENTURES utilises a secure online booking system for all bookings, payments, and refunds. Bookings are only confirmed once payment is successfully completed. To increase the likelihood of successful bookings, clients are strongly advised to pre-arrange payment with their banks and notify them accordingly.

Please note that both US and UK banks tend to flag and block payments, particularly in the afternoon and evening, when larger amounts are involved. This precautionary measure could trigger a fraud alert, requiring you to contact your bank and confirm that the transaction is legitimate and related to travel. In such cases, you will need to call your bank, explain the nature of the payment, and request them to release the hold on your account. To minimize the risk of encountering these issues, it is advisable to make payments earlier in the day whenever feasible. Additionally, we recommend reaching out to your bank in advance to inform them about your upcoming travel-related transactions, ensuring a smoother booking process.

### 7. Travel Insurance

While travel insurance is not mandatory for our 2027 tours, we strongly recommend obtaining medical coverage for the duration of your stay in France. Travel insurance that includes coverage for cancellation, curtailment, personal liability, illness, loss of luggage, and personal belongings is highly advised. Please ensure that your policy covers all activities listed in the itinerary. ZEBRA ADVENTURES does not arrange travel insurance; it is the sole responsibility of each traveller to organise their own coverage.

### 8. Flights

Flights usually open 12 months before your arrival date. Once ZEBRA ADVENTURES receives your booking confirmation, you can expect to receive an email within 24 hours with airline suggestions. In the meantime, we would highly recommend you keep an eye on flight options and prices. Summer in Europe is peak season, and therefore prices will increase nearer the date, and availability may become limited. Please contact us if you need advice, we can refer you to our trusted travel agent; however, we do not get involved in the booking of flights, and ZEBRA ADVENTURES cannot be held responsible for any errors in the booking of your flights. ZEBRA ADVENTURES will not be responsible for any flight booking or cancellation of flights due to error, tour cancellation or any other event. Flight details are due before 3 June 2027.

#### 9. Tour Details

International flight details, medical form and all other required details are due before or on 3 June 2027. If your flight details and your medical form are not received by ZEBRA ADVENTURES before or on 3 June 2027, ZEBRA ADVENTURES reserves the right to cancel your booking and the participant acknowledges that their spot on the tour will be forfeited, and full penalties will apply.

#### 10. Fitness

Due to the nature of our itinerary, a moderate fitness level is required. We strongly encourage every person on tour to participate in all daily activities to enhance their group travel experience.

#### 11. Medical Form

You will receive a basic medical form to complete roughly four months before your arrival in France. If you have received any medical treatment or sustained any injuries within six months before you arrive in France, we require a 'fit to fly' letter from your GP. This is to help you while in France, as we do not want you to miss out on any of our exciting activities, and to keep up with a jam-packed itinerary.

### 12. Vaccinations

It is essential to contact your GP a minimum of six weeks before travelling to France regarding vaccinations. The Travel Doctor is an interactive website providing specialist health information for travellers.

# 13. Indemnity Form

At our orientation meeting, you will be asked to sign an Indemnity Form before the tour starts. This form is an agreement that all guests have read the Travellers Code of Conduct which, will be provided. To exercise judgement and care at all times to ensure their own safety and that of their fellow travellers.

### 14. What is next?

Within 24 hours of making your booking, you will receive an email titled "What's Next?" This email serves as your comprehensive guide for the next steps to take. It covers practical details like airline suggestions for your journey to Chamonix, direct links to your account, information about pre-and post-accommodation if needed, gratuities and a real-time cost of living in France to aid in your planning and budgeting.

Additionally, a Medical Form ensures you're physically ready and able to join the group without any injuries, allowing you to keep up with the jam-packed itinerary, a Packing List to assist you in preparing for the journey, and lastly, a Questionnaire. We kindly request that everyone on the tour complete the questionnaire. The questions in the form help us get to know a bit more about the fantastic individuals joining us on this tour.

# 15. All our tours are protected - Financial Insolvency Insurance (FII) & peace of mind
